

Transparency International shall tighten up the fight against corruption.

We support Transparency International TI to establish an Award System, (1) to award **whistle blowers** with an **award of 10-15%** of the recovered fixed or current assets, and (2) to **exempt crown witnesses from punishment/impunity**, when they pay back their assets. (3) If the crown witnesses provide more information and the governments can retrieve assets, they shall be **entitled to receive an award of 10-15% of recovered assets, as well.**

We support Whistle blowers and Crown witnesses as an accountable and reliable **Trustee organization.**

We support, coordinate and render the pieces of evidences on behalf of our *non-named clients* between the Donors. Ministries of Justice, and other aggrieved Parties, to ensure to recover the plenty of unjust enrichments successfully.

We will safeguard the Award of the **recovered Assets**, that the awards will be paid to the Whistle blowers and the **impunity** of the Crown Witnesses is secured.

A Trustee / Liaison Cooperation partner must also survive, therefore we request for the **protective services an Honorarium**, however on a basis on success.

We do not request any advanced payments. Our risk shall be honoured later on.

Following procedure may be set up:

- a - Contract / escrow order / appointment as a Trustee based on reliable German Jurisdiction.
- b - Support as a Mediator between the Data provider and the aggrieved Parties
- c - We will anonymized the rendered personal data, and make sure, that nobody will be able to trace back our electronic signal and the source of information giver with the required documentary evidences.
- d - Meetings with the aggrieved parties and ministries of justice + finance
- e - Ensure protection of the information giver by the governments
- f - If all prerequisites are fulfilled in writing and endorsed by the ministries
- g - Law suit + Conviction / Verdict
- l - Payment of the 10-15% award of recovered monies,  
e.g. 10% out of 25 Million recovered assets = 2.500.000 Euro.
- j - Payment for our Services either time-bound or 15% out of the award amount  
15% out of 2,5 Million Euro = 375.000 Euro or according to time-input (600 Euro per hour) and incidental expenditures. The lowest amount as a fair deal will be due to us.
